Organizations would have the ability to weigh in should another vendor present to do a similar venue; ie the Lions would be able to review and reject any proposed food vendors that they deemed competitive to their efforts. Town Board to sign contracts as the town is ultimately responsible for events. Organization to donate money to town and town to pay and sign contracts. Cookie to contact president of each advisory organization and let them designate who should receive the meeting agenda/times. Unanimous consent for Ted to make changes to resolution to present to the Town Board on January 11, 2021 with final being emailed to the 5 Independence Day committee members.
- 8. Review proposed letterhead. Change vice chair to co-chair. Remove Fish and Wildlife Club, local youth group, prime timers, women's service club. Add UCC Thrift Shop and St Germain Community LLC. Ted will make appropriate changes.
