- 5. Approval of minutes of last meeting: Motion by Jimmy Vogel to approve, 2<sup>nd</sup> by Mary Platner, motion approved.
- 6. Citizens' Concerns: None
- 7. Bike Trail Items
  - A. Bike Station Update: Jimmy Vogel placed gravel at site and next week will place granite. Thoughts are to move Chamber Kiosk and donation box behind bike station.
  - B. Trail Signage: Signs will be blue to match work station. Anne Small said that Badger sign is slow. Map sign to be on kiosk. Signs posts have been purchased in anticipation of sign delivery. Digger's Hotline will have to be called for some of the sign locations.
  - C. Survey work: Jim Swenson reported that the town board approved the contract with Eagle Landmark surveying. Marion Janssen to contact the company to confirm the contract.
