- 1. Call to Order: Chairman Tom Christensen called the meeting to order at 6:00 P.M.
- 2. Pledge of Allegiance
- **3. Roll Call, Establish a Quorum:** Tom Christensen, Doug Olson, Ted Ritter, Jim Swenson, Brian Cooper, Marion Janssen, town treasurer, Tom Martens, town clerk. There were also 3 other people in attendance.
- **4. Open Meeting Verification:** Mr. Christensen noted that he had posted the meeting agenda at three locations in town on July 30, 2018 before 6:00 P.M.
- **5. Approval of the Agenda:** Motion Olson seconded Cooper that the agenda be approved in any order at the discretion of the chairman. By a voice vote: Yes -5, No -0. Motion carried.
