  - c. Adopt amendments to Chapter 1 Zoning and Chapter 3 Mobile Homes & Manufactured Housing (following 6:00PM public hearing) Public comments have been received. Discussion: Hearing process does not need to be restarted, recommendation of zoning committee will be made to board. The motion passed by voice vote unanimously.
