- 4. Discussion/Action items:
 - **a.** Assignment of a member to prepare meeting minutes Strom has agreed to take on the role of Secretary to keep track and record minutes. Motion by Anderson for Strom to take on the Secretary role. Second by Koziatek. Motion passed Unanimously. Discussion None.
 - **b.** Welcome our newest Member Penny Strom. Mortag introduced Strom to the committee and welcomed her.
 - c. Veteran's Memorial Quotes Needed for root removal and need to contact Irrigation Company. The removal of the tree roots was not in the original quote of work performed by Lumberjacks. Karen Anderson will contact a contractor (Jordon stump grinding) to receive a revised quote to finish the project. Mortag will contact the irrigation company to flag lines once a quote is received.

- h. Request funds from the town to replace broken pieces of playground equipment and new wood chips. Koziatek will contact Midstate on different types of mulch. Mortag will request funds from the town board to replace broken pieces of equipment quoted by Midstate, including interactive boards, swings, sandbox fossils and new signs.
- i. Discuss kids fundraising efforts and request town board to place funds in a town bank account. Discussion on moving the kids fundraising account to be included in the town boards reporting. A special line item will be requested by Mortag in the towns budget.
