- 1) Anne Small called the meeting to order at 5:33 PM

- 9) Fern Ridge Trail
 - a) Trail report: Jim Swenson announced that the new parking lot has been plowed and that the gate is now left open. Anne Small stated that she put up map signs and trail markers for the two loops.
 - b) Snowshoe event planning Jan 18, 2020 1:00-4:00 pm: Jimmy Vogel said it would be good to have vinyl banners for the event that could be placed on the Juve Rd sigs.
